JOB RESPONSIBILITIES

- Oversees the overall planning, direction and coordination of operations and functional programs areas of the Transportation Security Operations Center and the Systems Operation Control Section, Law Enforcement Information Coordination Section, and Security Assessments Section.
- Maximizes law enforcement resources that are responsive to a dynamic, risk-based management strategy and deploys appropriate assets.
- Oversees the national transportation infrastructure by managing a round-the-clock security operations center and maintaining operational awareness of the nation's critical infrastructures and key resources.
- Supports counterterrorism and investigative operations by leading intelligence gathering efforts and participating in multilateral law enforcement and counterterrorism efforts.
- Represents LE/FAMS in matters involving Congress, DHS, TSA, other government entities, and the private sector. Creates a robust information sharing environment and conducts high level briefings.
- Mitigates risk by implementing vulnerability assessments and providing effective tactical operations, domain and situational awareness, immediate notification and initial response actions for threats and multi-modal incidents in the transportation sector.

EXECUTIVE CORE QUALIFICATIONS(ECQ)



- **ECQ 1: Leading Change.** This core qualification involves the ability to bring about strategic change, both within and outside the organization, to meet organizational goals. Inherent to this ECQ is the ability to establish an organizational vision and to implement it in a continuously changing environment.
- **ECQ 2: Leading People.** This core qualification involves the ability to lead people toward meeting the organization's vision, mission, and goals.
